## Property Tax Tips by Maria Pappas

Could you be in line for a property tax refund? There are a number of reasons to check.

In fact, the number is roughly \$150 million!

Chances are, someone you know accidentally double-paid their property taxes - or was not credited for all of the tax-saving exemptions that they could have received.

That is why we urge you to check our Web site at [www.cookcountytreasurer.com](http://www.cookcountytreasurer.com) or to call our 24-hour automated telephone system at 312.443.5100 to perform a refund search. On the Web or on our phone system, follow the instructions and simply enter your 14-digit Property Index Number.

How do most overpayments happen? Often taxes are double-paid at refinancing when two institutions (like a title company and the new mortgage company) pay the same tax bill. Other times, homeowners pay the tax bills that already were paid by their mortgage companies.

Plus, thousands more people each year fail to seek common exemptions (like the homeowner exemption,

senior exemption or the senior-citizen assessment freeze) that would cut hundreds of dollars, sometimes thousands, off their tax bills.

State law lets homeowners go back three years and claim these exemptions, and our Web site at [www.cook-countytreasurer.com](http://www.cook-countytreasurer.com) allows you to see a history of exemptions on a PIN. If you see an exemption that you should have received in the last three years, you still may apply to the Assessor's Office. If the Assessor approves the application, the record is forwarded to the Treasurer's Office to process the refund.

What's important is that taxpayers take the time to search and file the necessary applications. Like I said, there are about \$150 million worth of good reasons.
